# **Disability Related Expenditure (DRE)**

# This information sheet may be useful for families who are:

- Looking for information about what Disability Related Expenditure (DRE) is and what could be considered as DRE.
- Wanting to requesting a DRE assessment for their relative.

## What is Disability Related Expenditure?

If your relative receives care and support funded by their Local Authority (Social Services) they may have to contribute towards the cost of this care. The amount they contribute is calculated during a financial assessment.

As part of the financial assessment the Local Authority (LA) is required to consider Disability Related Expenditure (DRE). Disability Related Expenditure is the extra costs that arise as a result of disability. For example, if your relative needs several changes of clothing each day, there are additional costs for laundry, wear and tear on the washing machine and tumble dryer, electricity costs etc. The LA must take all of these costs into account when deciding how much you pay towards your care costs. In practical terms this means that these costs will be deducted from the total amount your relative is required to pay.

The Care and Support Statutory Guidance (updated in January 2022) states that 'any reasonable costs directly related to a person's disability should be included'.

The Care Act and the Guidance does not provide an exhaustive list of what should be considered as DRE but costs could include:

- Cost of specialist items
- Entry to specialist activities

- Accessing local amenities that promote inclusion if stated in the Care Plan
- Additional cleaning materials/laundry detergent due to soiling/urinating
- Above average usage of gas/electricity/water due to additional laundry
- Special clothing/special bedding
- Cost of special dietary products
- Cost of replacement items caused by challenging behaviour.
- Transport costs to places specified in your relative's care plan

## **Cost of Living Crisis and DRE**

Many families are finding that the amount disregarded as DRE during their financial assessment no longer covers the real cost of these items. This is especially the case with utility bills.

If you feel that your relative's disability related costs have increased you can request a disability related expenditure assessment to update these costs. This could result in a reduction in the amount your relative is required to contribute towards their care and support. The template letter on the following pages has been created to use to request this from your relative's social worker.



If your relative receives certain benefits, has a water meter and uses a lot of water due to their disability they may be eligible for the WaterSure scheme which caps the amount they can be charged for their water usage. This can make a significant difference to some families and individuals. For more information please see WaterSure scheme – help with paying water bills - Citizens Advice.

#### **Template letter to request Disability Related Expenditure assessment**

The Care and Support Statutory Guidance (updated January 2022) states that 'any reasonable costs directly related to a person's disability should be included' therefore, I believe the above information supports my request for a disability related expenditure assessment and should be considered.

Additionally, The Care and Support Statutory Guidance, Annex C, 40) (xii) states that the local authority should include other transport costs necessitated by illness or disability, including costs of transport to day centres, over and above the mobility component of DLA or PIP and I would like for this to be included during your assessment process:
